Based on the strong balance sheet, the Board has proposed an increased dividend of SEK 1.40 per share", says **Katarina Tell**, President & CEO.*

"In addition to these financial milestones, our share was included in the OMX Stockholm Benchmark™ Index that measures the performance of a selection of the largest and most traded securities listed on Nasdaq Stockholm. I'm very proud of our people, who made an eventful and transformational year so successful. We entered 2026 as a more focused and more efficient Cloetta", concludes Katarina Tell.
